(Revelstoke, Summerland, and Osoyoos) – Members of Osoyoos Credit Union, Revelstoke Credit Union, and Summerland Credit Union will head to the polls to vote on the proposed merger of the three credit unions, after receiving consent from the BC Financial Services Authority (BCFSA).

The three credit unions announced their intent to merge in June, 2024. Since then, they've been working closely together, laying a strong foundation and thoughtfully planning for a successful future. With regulator consent now in place, they are ready to bring the proposed merger forward for member approval.

"We believe that merging will strengthen our ability to serve and support our members at every stage of life," says Alan Chell, Board Chair of Revelstoke Credit Union. "By bringing our combined resources and expertise to the table, we're confident that we can meet the challenges of today and seize the opportunities of tomorrow."

Summerland Credit Union Board Chair Lorrie Forde echoes this sentiment, stating, "Our focus has always been on people. By coming together, we're building a stronger foundation-one that empowers our members, strengthens our communities, and sets us up for long-term success."
